

## Job description & Role: Director Business & Policy

### Who we are and what we do

The Federation of European Microbiological Society (FEMS) is a coalition of more than 50 Member Societies from 38 countries, a diverse network of 30,000 individual microbiologists. Our central office with a small international team is based in Delft but we work with hundreds of individual scientists, partners, and suppliers across the globe. Our commitment is to support microbiologists, to promote the best in microbiological research and knowledge, and to bring microbiologists together to share that knowledge.

FEMS is a not-for-profit organization, which reinvests its income to support microbiologists throughout their careers. It does this through its grant schemes, by publishing and promoting scientific research in our journals and by organizing and supporting events to bring scientists together.

### Director of Business and Policy:

We are looking for an established science policy advocate who can bring an experienced non-academic dimension to the Board of Directors and who will:

- Have oversight of any Business/Policy sub-committee/s or networks that may arise
- Contribute to network/partnership development on Policy, Business, funding, and professional development issues
- to take part or to delegate a qualified person for the FEMS Awards Committee in the field of innovation

### Your skills and experience:

- Experience in public and/or science policy, national or international innovation initiatives or commercial/entrepreneurial/social enterprise
- Extensive network among microbiology professionals, ideally across sectors (academia, policy, industry)
- Strong record in knowledge exchange/collaboration between business and academia
- Sufficient commitment to the role
- Willingness and capacity to contribute to the administrative aspects of the relevant portfolio(s)
- Good networking skills, extensive contacts, and political and cultural sensitivity
- An open, forward-looking approach to microbiology research and related professions

- Collegiate and professional attitude, ability to work across cultural, sectoral, and professional boundaries and ability to retain an oversight (hands-off) function in relation to the Company's operations
- Desire to work in a cross-disciplinary, cross-sectoral, and cross-cultural environment in a spirit of mutual respect and collaboration

### **Time commitment**

Trustees are required to attend four Board meetings per year that will largely be in-person meetings. Most in person meetings take place in Delft, the Netherlands, and the fourth at the annual Council meeting that varies location throughout Europe. The Director of Business and Policy may be asked to represent the organization at events worldwide or take part in *ad hoc* meetings.

As well as attending meetings in person, Trustees perform some of their duties remotely, including receiving and analysing regular updates on the performance of the organization. The term of office is for three years, with the option of serving for a further term of three years.

### **Trustee Role Description**

FEMS is registered in the UK as both a limited company and a registered charity. As a result, the Directors of the FEMS company are also Trustees of the FEMS charity. FEMS Directors/Trustees are responsible for ensuring that the organization is managed effectively, remains solvent, and delivers its strategic and charitable objectives. Trustees bring expertise, leadership, and prestige to the Federation. The Board of Trustees is also a potential source of expertise and support to FEMS employees. As required by the UK Charity Commission, all Trustees must familiarize themselves with the Articles of the Company and understand the importance of adhering to the processes detailed therein. The Trustees remain accountable and responsible for the governance of the Company and must retain clear oversight of it.

### **Benefits of becoming a Trustee**

FEMS Trustees work as part of a multi-national and multicultural team, where they contribute to supporting FEMS and advancing microbiology. Trustees' work is supported by a dynamic and motivated team of FEMS employees (based in Delft, The Netherlands). Trustees bring their talent, experience to the Federation, and develop skills and networks as part of the role. All Trusteeships are voluntary without financial support except for reimbursement of reasonable expenses incurred in performing their duties, in accordance with the FEMS expenses policy.
