FEMS supports microbiologists, offering grant schemes, publishing scientific research in its Journals, and organizing events. As a Board Member, you will bring expertise and leadership to FEMS. This is a unique opportunity to help shape the future of FEMS, support microbiologists throughout their careers, and be a part of advancing microbiological research and knowledge globally.

Role & responsibilities

The primary focus of the FEMS Board is to govern the Federation, ensuring financial oversight and regularly evaluating that programs and services aligned with its strategic plan. You may also be asked to play an active role as the liaison with a subcommittee(s) of FEMS, based on your area of expertise or experience.

It is a commitment requiring attendance and active participation in the scheduled meetings of the Board (around 4 in-person, mostly in Delft and additional ones online) and a willingness to represent FEMS through participation in projects and conferences.

All Board member positions are voluntary without economic support except for reimbursement of reasonable expenses incurred in performing their duties, in accordance with the FEMS expenses policy.

- FEMS also encourages those with event programme committee experience and/or developing education projects to apply.
